Location

The site occupies a prominent position on the corner of Friston Avenue and Ladywood Middleway on the edge of Birmingham city centre and close to the affluent suburb of Edgbaston. The area is mixed commercial and residential in character with the creation of 271 apartments at No. 1 Hagley Road and the Broadway Plaza leisure complex opposite the site. The redevelopment of the former **Tesco** store and office building is immediately adjoining which will comprise 23,225 sq m (250,000 sq ft) of retail space, a gym and offices with 214 residential apartments on the upper floors.

Description

The site comprises a former petrol filling station which is to be redeveloped to provide a drive-thru unit to meet an occupier's requirements and will benefit from 15 demised parking spaces in the adjoining car park.


