

The Proposed Development

The Subject Site

The Development Partnership of Lidl, Kingsmead and AS Homes (Scotland) is looking to regenerate the town centre of Alexandria on the Mitchell Way site through a mixed use development of retail and residential uses.

The aim of the scheme is to deliver a new, modern and spacious development including a brand new Lidl store, and retail shop units with new housing above immediately adjacent, all as per the draft layout shown.



The site is bounded to the east by Bank Street, to the north by Mitchell Way and to the west by the Co-operative Food Store and St Andrew's Parish Church.

The Proposed Development

The new Lidl store will be a single storey retail property comprising 1,257 sq. m of sales area with the new retail shops comprising around 10 units of between 93 and 232 sq. m (1,000 sq. ft. to 2,500 sq. ft.) for a range of tenants and will include the rehousing of Mitchell Street traders as well as attracting new business into the town, while the residential development above will provide 33 flats (approximately).

This marks an important investment in Alexandria in terms of new retail and commercial development as well as the creation of new flats all within an improved urban realm.

A new shoppers car park will be delivered with the store of around 138 spaces with easy access to the remainder of the town centre.

Lidl's investment alone will create up to 40 new jobs at a minimum of £8.25 per hour and with no staff operating on zero-hour contracts.

The Lidl will additionally contain:

- Restricted product lines designed to complement the town centre offer
- Wide and accessible aisles and customer toilets

Overall, the development will provide a new, bright environment for shoppers and other users of the town centre.

Community Consultation

We plan to lodge a planning application for this development in Summer (July) 2019 We hope to have a determination by the end of 2019.

The Development Partnership would like to hear your views on the proposals for this town centre redevelopment. As such we invite members of the community to attend a public exhibition which provides an opportunity for local residents and stakeholders to view the plans and discuss the development in more detail with members of the Development Partnership.
