#### Location

The property sits on a well established industrial/trade estate just off Concord Road and approximately 0.25 mile south of the intersection with the A40 Western Avenue.

The A40 leads 6 miles east to Central London and west to the M40, and subsequently the M25 J16, 11 miles west. London's largest business park, Park Royal, sits on the opposite side of the A40.

The surrounding area is largely employment focused with a number of motor dealerships close by including those representing **Aston Martin**, **Jaguar/Land Rover**, **Nissan** and **Renault**. Royale Leisure Park sits a short distance north.

## **Description**

The property comprises a terraced unit of steel portal frame construction together with a front yard which has been secured by palisade fencing.

The unit benefits from unpainted concrete floor, access via a single up and over door with lighting by florescent strip lighting and translucent ceiling panels.

A two storey office / ancillary area has been formed at the front of the unit.

#### Tenure

Leasehold.

The unit is held on a lease with security of tenure under the Landlord and Tenant Act 1954, due to expire on 01 August 2023, on a passing rent of £100,000 per annum.


